Dear Members of the CIArb London Branch,

It would be a privilege to represent your interests and contribute to the important work of the Committee. As explained below, I believe we need to promote our new Arbitration Act, provide a comprehensive programme of events, and address current developments.

As London-based practitioners will no doubt be aware, the Arbitration Act 1996 is being replaced by the Arbitration Act 2025. Although we are likely to be familiar with these changes, the replacement of this significant legislation risks creating a perception of uncertainty overseas. As members based in London, we are responsible for ensuring that the international arbitration community understands these changes and (hopefully) agrees that these amendments enhance London's arbitration offering. We should not rely on overseas-based practitioners to champion our new Arbitration Act.

Having written several articles on these amendments, hosted an event with Dr Nathan Tamblyn (who led the Law Commission's review of the reforms), and presented on these changes abroad, I am well placed to promote the Arbitration Act 2025 (and indeed London as a seat) internationally. I will be committed to promoting the new Act as part of the Committee, including by organising events, webinars, and publications.

In addition to supporting the promotion of this recent legislative change, I believe that fostering a strong, connected professional community is crucial for the success of our members. I have personally benefited from the Institute's training and networking opportunities, from storytelling workshops to the Institute's Diploma in International Arbitration. These events are vital for the professional development of our members, and I would be delighted to contribute to organising and delivering more of them. I strongly believe that the international dimension of arbitration is one of its core pillars and should be at the top of the Committee's agenda, along with AI and tech, the rapid developments in which already present unique opportunities and challenges.

Lastly, alongside international arbitration, I specialise in financial sanctions. The growing complexity and volume of sanctions has meant that their effects are more frequently felt in arbitration. Sanctions now regularly impact arbitrators, the parties, and the disputes themselves. With my experience in advising on sanctions compliance and handling sanctions-related disputes, I will help the Committee stay informed of these developments and will support the Institute and its members in navigating this rapidly evolving and complex field.

I will devote sufficient time, diligence, and industry to the work of the Committee.
